 - iii. Jill says students to be called by Deans and Cabinet
 - iv. Marketing? Digital campaigns going out.
 - v. AJC article about CSU large drop Can we do counter marketing? We had the greatest decline. Targeted marketing.
 - vi. Work on engagement too.
- Remarks and Q & A from Interim Vice President of Academic Affairs and Provost Dr. Lane
 - a. Composition of committees left to colleges.
 - Commencement Ceremonies on Friday are full, some spots on Saturday morning, more in the afternoon.
- 3. Parking fee increase discussion and Q&A, Chief of Police John Keener
 - a. He may not be in the Teams. Get him at December 12th meeting.
- 4. Discussion of CSU AAUP letter demanding greater administration transparency, Dr. Kathryn Pratt Russell-President of the CSU chapter of AAUP
 - a. Long term faculty member.
 - b. Ask Senate to request administration for transparency on this process.

- Discussion: Faculty input in this process. Faculty perfunctory involvement in Strategic Alignment and decision making. Need consistency. No guidelines.
- ii. Shared Governance? No transparency
- iii. Keith Miller Task force from CoB had mixed faculty and staff involved. Maximum ability to maintain student services and minimize impact. Other colleges? Not intentional talk to your peers Maybe other schools. The only thing wasn't conveyed was individual names. Needs to go through process. If told people ahead of time too much anguish. Survey faculty on summer pay cut to save a job, for instance. As we move forward use admin some admins are faculty members. Dept chairs are faculty members.
- iv. Kathryn Tenured faculty are not being threatened with losing their jobs.
- v. Celeste as leader you are assigned. Frustrating to hear it wasn't each person. Denying responsibility. Process should be standard that was done at CoB. Can't absolve admin just because they are faculty too. Still have the power. Keith followed the process as given by the provost. Dr. Lane says at some point we have to be realistic. Trying to save as many people as possible. Some programs have declined. Focus on communication and transparency. Not a lack of trust. All are stressed out. Dr. Momayezi has gone to every department. He is coming over to answer every question.
- vi. Kathryn trust me This fall Dean went around but said lecturers and senior lecturers and tenure track folks. Why was one tenure track employee non-removed?
- vii. Jill Budget cuts, process for non-renewal BOR policy, Lecturers nontenure track 3rd year or more contract August 1, 2nd November 1st 6 or more 180 days Jan or Feb. Board policy dates. Standard practice. Current bylaws do not allow discussion of individual people.
- viii. Kathryn No reasons have been given for non-renewal. That person got reasons through open records request, and they did not get info per policy.
 - ix. CSU HR is no reason necessary non-renewal. Letter of policy has been followed.
 - x. Sam Faculty morale? What reason when asked for new job why have you not been renewed?
 - xi. President this is our practice and our policy Not discussing individual person.
- xii. Has that faculty member reached out to AAUP to convene panel? Been discussed.
- xiii. Nasser yes, there were guidelines given by Provost and BOR. How to have least effect on programs. Why should we hide anything?
- xiv. Eric What strategy should be used? What is the CoAS do to make us more resilient? Discussion of future cuts? Nasser no info yet. Met for

- a whole month. Submitted to Provost but can't share Academic Alignment plan Jill --can be shared. Work on enrollment. Will face more cuts if not! Is it marketing? Recruiting? Staffing. All got to work on more enrollment.
- xv. Sam We work very hard with recruitment event told last minute that graduate staff cut. Spring budget cuts will happen. It's perception.
- xvi. What is the next budget cut? Do not know.
- xvii. Why did graduate admissions get restructured?
- xviii. We will make assumptions no matter what.
- xix. Jill Formula funding some buckets count more enrollment and graduate programs. So, enrollment down makes it worse. One Graduate faculty is saying we'd rather do the recruitment because we know the program best instead of a body sitting there handing out brochures.
- xx. Eric Thanks for AAUP and their letter. Have AAUP input at meetings
- xxi. Macro level get more \$? Pres. Yes looking at other opportunities. Stuck with formula funding. Grant funding, etc.
- xxii. Celeste Want to be informed of the decisions.
- xxiii. Antoinette AAUP report to FAC instead of Fac Senate?
- xxiv. Nasser appreciates our involvement Improve recruitment.
