 about the governor's signature of the campus carry bill "Dear presidents, provosts and police
 chiefs:

Today, Governor Deal signed House Bill 280, the "campus carry" legislation. As we near the July 1st effective date, the system office will be issuing implementation guidance to all institutions. Please do not make any changes to your policies until you receive this final guidance. We recognize that many have strong feelings about this new law. It is important that we all work together across our campuses to implement the new law appropriately and continue to provide a top-quality education to our students.

Chancellor" Chairs in the College of Arts and Sciences expressed concern last week about this policy change. What follows is a text of my response to those colleagues: "And I will indeed be crafting a general campus response to this change in legislation. We have many of the same specific questions posed in Dr. Campbell's e-mail, and will be working with the system office to address them as quickly and as clearly as possible. Several of us have reached out to colleagues in others campus carry states during the last several years of the debate, and hope to find some assistance in interpretation here also. In the meantime, my thanks to each of you for your leadership that will help us all navigate an outcome that most of us opposed, but now find to be the law July 1. More as we have it." At this point, we still await response from the system office, and will share that information with the campus as soon as we receive it.
