Modification of Course (Course Description) (1)	MUSC 1002 Music Fundamentals	A beginning study in reading, notation, and execution of fundamentals of music relating to pitch, rhythm, and tonality. The course is intended for non-music majors and is open to all students. May not be counted for credit towards fulfillment of any major or minor curriculum in music.

The Bachelor of Arts in Performing Arts was created in 2014 in response to the former degrees in Music and Theatre being listed on a University System of Georgia Board of Regents report on "underperforming" degrees within the system that did not produce 10 graduates annually. There were hundreds of degrees throughout the system on this list. There were many Music and Theatre degrees at many institutions listed, a number of them producing far fewer graduates annually than However, some stakeholders, including the national accreditor for the discipline of Music, the National Association of Schools of Music, which accredits Clayton State University, have objected to the label of "Performing Arts" as a major. These objections can be summarized as follows: 1) Performing Arts is not a historically accepted and generally used major label throughout American higher education, and 2) as a label for Clayton State's curricula, it is misleading in several respects. It would suggest that students majoring in Performing Arts study multiple performing arts and not merely one. NASM's objection on this point has merit; while the BA-PA allows students to count MUSC, THEA, and DANC courses toward the major in the Music and Theatre concentrations, it does not require Music concentration students to take THEA or DANC courses or Theatre students to take MUSC or DANC courses or Theatre students to take MUSC or DANC courses, and Music Education concentration students receiving a major in "Performing Arts" well might not be taking coursework in multiple performing arts disciplines, and indeed the Music Education students receiving a major in "Performing Arts" well might not be taking coursework in multiple performing arts disciplines, and indeed the Music Education students certainly are not doing so. NASM also contends that, by labeling all three curricula as concentrations of the same major, Clayton State is conflating two completely different kinds of degrees. The faculty expert in this field is requesting that the prerequisites be changed to Organic Chemistry I (CHEM 2411), Organic Chemistry Lab I (CHEM 2411L), and Organic Chemistry Lab II (CHEM 2412L which can be taken concurrently) to match the prerequisites of the associated lecture course Inorganic Chemistry (CHEM 4301) as well as meet the needs of this course. A student cannot successfully complete this course without the lecture, which explains why CHEM 4301 must be taken concurrently. However, a student can take the lecture course without this lab course, which is why CHEM 4301 does not have CHEM 4403L as a prerequisite. CHEM 2411 and CHEM 2411L sufficiently prepare a student for this course such that CHEM 2412 and 2412L are not required as prerequisites for CHEM 4403 or 4403L. 		FOSC 3100 has only one faculty member qualified to teach this class but cannot do so on a regular basis due to other commitments. This puts the students who are preparing to graduate at a disadvantage. Making it an elective course will not cause any problems if not offered regularly.		
		In addition, students are currently required to have a minimum number of one elective course with the FOSC prefix but no elective course with the CRJU prefix. In order to ensure that students take enough FOSC and CRJU courses to fulfil the requirements of the minor, we would like to change the requirement to a minimum of one FOSC prefix and one CRJU prefix		
		from the proposed twelve elective hours. This allows a student the flexibility to choose which FOSC and CRJU course fits their needs, as well as allowing six additional hours that a student can tailor to their career path from a range of different classes that pertain to forensic science.
