The Bachelor of Arts in Performing Arts was created in 2014 in response to the former degrees in Music and Theatre being listed on a University System of Georgia Board of Regents report on "underperforming" degrees within the system that did not produce 10 graduates annually. There were hundreds of degrees throughout the system on this list. There were many Music and Theatre degrees at many institutions listed, a number of them producing far fewer graduates annually than However, some stakeholders, including the national accreditor for the discipline of Music, the National Association of Schools of Music, which accredits Clayton State University, have objected to the label of "Performing Arts" as a major. historically accepted and generally used major label throughout American higher education, and 2) as a label for Clayton State's curricula, it is misleading in several respects. It would suggest that students majoring in Performing Arts study multiple performing arts and not merely one. NASM's objection on this point has merit; while the BA-PA allows students to count MUSC, THEA, and DANC courses toward the major in the Music and Theatre concentrations, it does not require Music concentration students to take THEA or DANC courses or Theatre students to take MUSC or DANC courses, and Music Education concentration students really cannot take any courses in other performing arts, as their entire sequence of courses is fixed by state requirements for teacher certification. So students receiving a major in "Performing Arts" well might not be taking coursework in multiple performing arts disciplines, and indeed the Music Education students certainly are not doing so.

NASM also contends that, by labeling all three curricula as concentrations of the same major, Clayton State is conflating two completely different kinds of degrees. The Music and Theatre concentrations of the BA-PA are clearly what NASM (and its disciplinary equivalent in Theatre, NAST) would label liberal arts degrees with a major in an arts discipline. The Music Education concentration, however (our largest and most popular concentration in the BA-PA, it should be noted), essentially is a professional degree (most often packaged as a Bachelor of Music in this field, though Bachelor of Arts professional degrees also do exist) leading to a professional certification and not allowing students the kind of elective choice that is typical of liberal arts degrees. By labeling all three curricula as concentrations of the same degree, NASM contends, Clayton State is intentionally confusing types of degrees that should be kept separate. We have seen evidence among prospective and current students suggesting NASM's contention that the lack of distinction in the labeling of the different curricula confuses students about requirements and expectations actually is correct.

Finally, the current Executive Vice Chancellor for Academic Affairs and Chief Academic Officer has indicated the importance of using the appropriate degree designations for degrees what a student's academic credentials would be strengthened by a major instead of a concentration or where accreditation issues would be impacted by a lack of a

s tt	distinct major. In these cases, the Institution would still be allowed to combine enrollment numbers for the distinct majors into one number for the purposes of reporting program production. To the department of Performing Arts, this seems like the proverbial winwin opportunity, and we hope that our request to change the nomenclature of our existing curricula which, to repeat, will remain unchanged) will be approved speedily.

Modification of Major (Second Reading)	History	The History faculty in the Department of Humanities has approved a simplification of the elective requirements for the history major. Previously, students were expected to choose from a list of specific classes. The limited list of classes often resulted in frequent course substitutions. Moreover, updates to the list were often required as other programs changed their course offerings. We are proposing to delete the specific list of classes and instead accept any 3000- to 4000-level course with the following prefixes: ART, CMS, COMM, AFAM, ENGL, POLS, THEA, SPAN, FREN, PHIL, HUMN, MUSC, SOCI, PSYC, ECON and WST. The faculty agreed any upper-level course with one of these prefixes would be a suitable elective for history majors.	Second Reading approved. Forward to Faculty Senate.

Modification of Minor (Second Reading)	Forensic Science Minor	In 2015, the Department of Chemistry and Physics started offering this minor. Since then, we have identified a number of errors in the curriculum. We have been making the necessary changes for the benefit of our students, as the minor is one of the highly recommended supplementary programs for a number of majors. FOSC 3100 has only one faculty member qualified to teach this class but cannot do so on a regular basis due to other commitments. This puts the students who are preparing to graduate at a disadvantage. Making it an elective course will not cause any problems if not offered regularly. In addition, students are currently required to have a minimum number of one elective course with the FOSC prefix but no elective course with the CRJU prefix. In order to ensure that students take enough FOSC and CRJU courses to fulfil the requirements of the minor, we would like to change the requirement to a minimum of one FOSC prefix and one CRJU prefix from the proposed twelve elective hours. This allows a student the flexibility to choose which FOSC and CRJU course fits their needs, as well as allowing six additional hours that a student can tailor to their career path from a range of different classes that pertain to forensic science. This course includes a detailed study of the anatomy of the human dentition and the bones of the skull with emphasis on the general therapeutic rationale for drug therapy, mechanisms of action, pharmacokinetic concepts, and pharmaco-dynamic principles. Students will identify important considerations in the health maintenance and management of patients with special emphasis on commonly prescribed oral health products.
