If parent(s) credit is denied, the parent can indicate on the form for the student to be reviewed for a potential additional Unsubsidized Loan based on classification and remaining eligibility. | It takes 24 hours for the school to receive. | It takes 24 hours for the school to receive. However, parent will know credit decision <i>immediately</i> after parent click SUBMIT . | It takes 24 hours for the school to receive. If you are a returning student and received loans at CSU within last 10 years, you DO NOT need to complete. Otherwise, students who are taking out loans for the 1st time MUST complete. | It takes 24 hours for the school to receive. Students who are taking out loans for the 1st time <u>MUST</u> complete.
