	This request is for a full-time Case Manager/Prevention Coordinator. This position will be
	responsible for 1) providing case management services for students with severe psychological
	issues and 2) coordinating CAPS' prevention programs in the areas of suicide, domestic violence,
	and sexual violence.
2)	Justification: Please provide a justification that discusses such things as support of the University's
	strategic plan or other institutional objectives. What impact will this request have on University
	programs and services? Can you redirect funds to meet this need?
	Through case management, CAPS will be able to provide services that will help prevent
	psychiatric hospitalization of students, provide, and coordinate post-discharge follow-up care.
	These services can help prevent students' academic performance from deteriorating, potentially
	preventing them from the need to withdraw or failing classes.
	Through prevention programming, CAPS can reach students who would not normally come into
	the counseling center, as well as provide educational campus-wide programming designed to
	reduce suicide behaviors, domestic violence, and sexual violence. These issues are commonly
	seen in students coming to CAPS for services. In addition, faculty and staff across campus are
	encountering students who are or who have experienced these issues; training to faculty and staff
	can help to meet the students' needs by referring them to CAPS and obtaining necessary services.
	Again, receiving needed services can help prevent students' academic performance from
	deteriorating to the point of failing grades, academic suspension, and dropping out.
	There are no current funds to redirect toward performing this service for students.

- 3) Metrics: Please describe how you plan to determine the effectiveness and measure the impact of the proposed funding.
 - 1. Case management of students with mental health issues will increase the potential for retention and academic success. These students will also experience a decrease in distress based on the Counseling Center Assess of Psychological Symptoms instrument.

- 2. Outreach and prevention programs will be offered across campus to a large variety of student organizations, classes, and departments.
- 3. Students who attend educational prevention programming will utilize counseling services at an increased rate.
- 4. Staff and faculty who attend trainings will report feeling more confident in dealing with students with mental health issues.
