Narrative Statement of Qualifications (to be completed by chair or dean):

1. What evidence exists that the coordinator has the qualifications and credentials for leadership in the development and review of the curriculum?

The coordinator has a doctorate in education with an emphasis in human resource development; his doctoral dissertation was an analysis of correctional training in the USA. He has taken several curriculum development courses at the doctoral level. He has a total of 14 years of university and statewide teaching and training experiences; he has been trained by the National Institute of Corrections Advanced Training for Trainers which included curriculum development. He has served on curriculum committees; has been responsible for coordinating and auditing training programs; and has been in charge for coordinating curriculum change and its delivery at a variety of organizational levels.

2. What evidence exists that the coordinator provides oversight for assessing the quality of the curriculum for the program and for ensuring that the curriculum and its delivery are educationally sound?

The curriculum for the BS in Criminal Justice program has been in existence for several years at Clayton State University. Curriculum changes include addition of courses related to Homeland Security,

Terrorism, Diversity, Ethics, Cybercrime Law & Investigations, and Professionalism. Because of CSU geographical location, week-end, evenings, and on-line courses being offered there is a range of students in the program with no-experience to several years of experiences with varying parts of the criminal justice system. When opportunity arises the coordinator is or will be actively involved in reviewing student evaluations of instructors for faculty teaching criminal justice courses in the program. The coordinator has also been tasked with the development of a graduate criminal justice degree program with the eventual potential of coordinating the graduate program.
