Explain use of the fee including major items funded by the fee: This fee funds food, space rental, and supplies for campus recruitment events including but not limited to the Laker Experience, Freshman Preview Day, Majors Monday, and Non-Trad Tuesday. The fee also covers the purchase of names for students that we recruit, annual contract of student recruitment software and processing tools, advertising, printing, and mailing.

Revenue in FY20: \$202,225.00

Expenditures in FY20: \$105,505.18

Surplus amount and suggested use: \$96,719.72

In the spring of 2020, plans were made to spend these funds on standard purchases (student name buys) as well as newer purchases related to virtual student recruitment (ex: mobile student acceptance letter with Full Measure), which were needed given the change in landscape once our recruitment travel and on-campus events were halted beginning in March. With the higher priority and focus of shifting our staff and operations to a completely remote work setup at the time, this unfortunately delayed most of these purchases past our deadlines to use FY20 funds. We experienced some delays with select vendors due to COVID-19 as well, but the planned purchases were made mostly using FY21 funds. Plans have been made to avoid a similar scenario in the future from the circumstances faced in the spring.
